#### V. FINANCIAL REPORT – Executive Director Dilorio

- A. March financials for the month of March 2025 were given to the Board prior to the meeting and reviewed at the meeting. March is the 12<sup>th</sup> month in the Fiscal Year End 2025.
- B. Occupancy
  - 1. Public Housing is 90.42% leased. There were seven move ins, and two move outs. There are twenty-four open units in the process of turnover. Unit turnovers remain to be the top priority.
  - 2. The Housing Choice Voucher Program is 89% leased with a total of 272 vouchers. Rebecca Brabaw, Leased Housing Coordinator is currently interviewing participants to fill the open vouchers.

#### VI. CAPITAL FUND - Executive Director Dilorio

- A. Executive Director Dilorio provided to the Board prior to the meeting a report on Capital Fund programs for Fiscal Year 2022, 2023, and 2024.
- B. The elevators for 42 Church and 51 Port Watson will be going out to bid shortly.

## VII. EXECUTIVE DIRECTOR'S REPORT - Executive Director Dilorio

- A. Executive Director Dilorio submitted an emergency funding grant opportunity through HAI insurance as well as a grant opportunity through HUD for emergency safety and security.
- B. Executive Director DiIorio and Ann Brown, Administrative Assistant, will be attending a PHA Web training in Florida on topics that include Housing Opportunity through Modernization Act (HOTMA), financials, and website, and many more.
- C. HOTMA will be in effect on June 1, 2025 and the Administrative Plan and Admissions and Continued Occupancy Policy will need to be updated prior to that date.
